## <u>Sub: Nodal Officers to deal with the grievances/ complaints received</u> <u>through 'SANTUSHT' Cell, Office of Hon'ble Minister for Labour &</u> <u>Employment – reg.</u>

It is brought into the notice of all Head of the Offices/ Controlling Officers/ Grievance Redressal Officers that 'SANTUSHT' Cell is a Grievance Monitoring Cell under direct control of Office of Hon'ble Minister for Labour & Employment (HLEM), Govt. of India wherein received grievances/ complaints are addressed.

It has been decided that the nominated Grievance Redressal Officer (GRO) at field offices and Headquarters shall be the Nodal Officer to deal and dispose of grievances/ complaints received from the 'SANTUSHT Cell', O/o HLEM also.

I have been directed to convey that these grievances/ complaints shall be qualitatively resolved within 7 (seven) days from the date of receipt under intimation to the petitioner/ complainant as per Standard Operating Procedure/ instructions on redressal of grievances issued by Headquarters letter bearing no. C-12/12/IVRS/2019-PG dated 08.12.2020 (*copy enclosed*).

The Head of the Offices/ Controlling Officers shall be responsible for strict compliance of this OM.
